Sri D. Suresh Babu told that many Members are asking to complete the Temple construction also with the same spirit. We have decided in earlier General Body Meeting to spend amount from the surplus fund in Movie Towers to revive the Temple. Sri K Ashok Kumar asked the amount which is spent for Temple is refundable to Society or not? Sri D. Suresh Babu replied that if any surplus fund comes in Temple donations from outside donors the same amount will be taken back as interest free loan. He requested if any Member wants to donate the amount for the temple are welcome. We will collect and complete the temple soon after completing major works in Movie Towers.

Sri D. Suresh Babu said, we cannot run the club with our 320 Members. We will have to take another 300 Members from outside known circles with Membership fee Rs.3 Lakhs without voting rights. He also assured members that only Society Members can contest as Board of Directors. The Members ship fee may also become Rs.5 Lakhs later, if club is run well.

He again told that we are expecting Occupancy Certificate in Feb.2019 after that we will start registrations.

Sri T. Bharadwaj told that we are trying to rectify the snags in our level. One of our Director gave 118 Snag Points but we have rectified 6 major snag points only.

The Meeting concluded with vote of thanks to the Chair.
